Entry Criteria

• The APNC is open to Australian wines only.

Wines must declare the following on the commercial label:

- a. Australian geographic region or sub-region as defined by the <u>Australian Geographic</u> <u>Indications</u>.
- b. Pinot Noir
- c. Vintage year
- The rules governing these declarations can be found here: <u>Compliance Guide</u>.
- If the wine is produced from grapes which originate outside a gazetted regional zone, please contact us on (03) 5989 2377.
- All vintages are eligible.
- Wines must be commercially bottled, and entries must be clearly labelled as per criteria defined above.
- All exhibits must conform to their respective State Acts and Commonwealth Acts which govern the manufacture of Australian wine including (but not limited to) the Label Integrity Program under the Wine Australia Corporation Act and Food Standards Code.
- Only still red table wines may be entered.
- There is no restriction on the number of entries per winery.
- Exhibits must be the property of the exhibitor at the time of entry.
- Each wine must have a minimum volume of **50 dozen** at time of entry.
- The organiser reserves the right to market and promote any wine entered in the APNC.
- It is a condition of entry that the MP Wine reserves the right to purchase award winning wines, up to 12 bottles, for promotional purposes at a nominal purchase price of \$150 per case including all taxes.
- All exhibits become the property of the organiser who may make exhibits available for other judging or promotional tastings.
- Entry fee \$125 (+ gst) for each wine entered.
- Entry fees will not be refunded if an exhibit is not received by the due date, withdrawn by the exhibitor after entry form lodgement, or the exhibit is disqualified by the Chief Steward.
- No entry will be accepted until receipt of the full entry fee.
- Wines may be refused entry or may be disqualified at the complete discretion of the Chief Steward and/or the Wine Show Committee.
- Each exhibit must consist of 3 x 750ml bottles for judging purposes.
- Any promotional opportunities will be forwarded to exhibitors for their consideration.
- Wines will be judged in blind regional brackets.
- Entries must be made via https://wineshow.awri.com.au/2024-australian-pinot-noir-challenge. Late entries will not be accepted.
- Whilst it is not required that the commercial label is affixed to the exhibit, it is strongly suggested that all wines have a label as they may be used for promotional photography and video.

Exhibit Labels

Exhibit labels and delivery labels will be forwarded to exhibitors via email on Monday 19 August. Exhibit labels must be fixed over the back label on all exhibits prior to delivery.

<u>Awards</u>

Australian Pinot Noir Challenge Trophy

The trophy for Australia's best regional Pinot Noir will be awarded to the top scored wine from the judging of all the Best of Region Trophy winners.

Best of Region

A Regional trophy will be awarded to the highest scoring wine from each region. Top gold wine (scoring 95 points or above) in any region may be eligible for a trophy.

Top 50 Tasting Event

If your wine is in the Top 50 scored wines, you will be invited to participate in a consumer tasting event on Saturday 5 October, held at Canvas House in South Melbourne. There is an additional fee of \$300 per wine to participate at this event. Invitations and information will be communicated to you post judging if eligible.

Scoring

Scores will be on a 100 point scale.

All scores will be published on the Australian Pinot Challenge website and sent to exhibitors via email with judges' comments for each wine entered post event. Wines receiving less than 85 points will be published without scores

Class 20: Any other Region not listed above 2022 & Older*

^{*}Wines that come from a GI not listed will be accepted in Class 19 and 20.
